


Action Taken: On August 13th, 2008, this Detective received from Detective Pinelli several faxes from "Condon & Skelly," the insurance company that insures Mr. Hallingby's collector cars. He has seventeen insured vehicles with them. Six of the vehicles do not list a location where they are stored. The remaining eleven all list "Sharon, CT" as the "Garage Location."

According to a representative of the insurance company, the company must know where all of the vehicles are stored and they have sent a letter to Mr. Hallingby advising him of that regulation and that he must comply to maintain the insurance on those vehicles.

On August 19th, 2008, Mr. Hallingby responded via e-mail to "Condon & Skelly" and stated that all of his collector vehicles are "kept in purpose built garages in Sharon, CT where we have a home." He further stated that "we have a caretaker that visits all the facilities daily." Mr. Hallingby also inquired as to why "Condon & Skelly" was specifically asking about the 1958 Ferrari 250PF with Vehicle Identification Number 0799GT.
