If there was a New Jersey Title, I will need a complete copy of the actual Title file if you can get a copy for me. We are looking for any paperwork of where the car came from and all documents used to register or title the car in NJ.

The car is a 1958 Ferrari (Valued at \$5,000,000.00). The car was stolen in Europe and somehow found its way here. In doing the Connecticut history, it showed a New Jersey Title. The VIN on the title was FER07 9958, for a 1958 FER 250 2 dr., it was supposedly issued on 12/09/1997 in the name of Jeffrey D. SCHWARTZ of 110 Tekening Dr, Tenafly, NJ 07670-1226. Control# K578474, and the numbers on the right lower corner on the front of the title are: EP EL973430290.

The car is currently titled/registered in Connecticut with the VIN listed as 0799. The actual True VIN is 079958.
